

## **YOUR Platform – Electronic Transfer Counterparties**

We are able to process electronic transfers where the ceding provider is part of the ATG (Altus Transfer Gateway) system. We can process them to Pensions when the ceding party is part of the Origo system.

This document provides lists of these providers. The names are also listed on the platform transfer interface, and that list may be, on occasion, updated more frequently as new vendors access these systems.

The lists in this document should be taken as a guide and assist in deciding when to provide transfer forms to clients in advance to avoid the risk of having to re-contact them once accounts are already open.

Some businesses operate a range of similarly named agencies so take care to check the provider and if in any doubt contact the Platform Operations team to check for eligible providers.

## **ISA and GIA electronic transfer counterparties**

Your Platform can accept only single name accounts currently. To transfer a joint GIA to two single name YOUR Platform GIAs there is a form required which is hosted on the YOUR website.
